Describe why your pool or spa is innovative and the difficulties that were overcome. You may choose to highlight any unique design elements or features, you may also elect to describe the degree of difficulty, including site access, lay of the land or builder requirements dealt with, etc.

Artistic Design, Desirability, Perceived Quality & Amenity:

Support your entry by describing how the design was developed, how it blends with the property, water/energy conservation values, is it a certified Water Neutral Pool, amenity achieved, etc.

You may also use this section to describe the outstanding features of your entry, including construction detail, hydraulic design, type of materials used in the interior, automation, landscaping, etc and how the pool or spa was located in relation to the surrounds and house.

Entry Guidelines:

Closing date for entries & full payment is 5pm Friday, 14th April 2017. This official SPASA Entry Form must be used for all 2017 Award Entries (Category number 1 – 26 inclusive).

Please complete one Entry Form per entry.

A minimum of 3 signatures must be provided on the cover sheet. All Pool & Spa category entries (1-26) must be accompanied by contractual evidence. Current SPASA contract: Page 6-10 (online also to include Certificate of Authentication). Previous version page 5-7 (builder, owner, details & price).

All pools and spas must have been completed between 1st January 2013 – 14th April 2017. Refer to the "Terms & Conditions of Entry" for full details.
