##### **Artistic Design, Desirability, Perceived Quality & Amenity:**

Support your entry by describing how the design was developed, how it blends with the property, water/energy conservation values, is it a certified Water Neutral Pool, amenity achieved, etc.

You may also use this section to describe the outstanding features of your entry, including construction detail, hydraulic design, type of materials used in the interior, automation, landscaping, etc and how the pool or spa was located in relation to the surrounds and house.

#### **Entry Guidelines:**

Closing date for entries & full payment is 5pm Friday, 14th April 2017. This official SPASA Entry Form must be used for category 29 Award entries. **Please complete one Entry Form per entry.**

A minimum of 3 signatures must be provided on the cover sheet, plus a copy of the Certificate of Final Inspection & the sales docket or SPASA Contract (ie: evidence of compliance & product sale and / or manufacture).

All portable spas must have been completed (installed) between 1st January 2013 – 14th April 2017. Refer to the "Terms & Conditions of Entry" for full details.
